
Title 21 U.S.C. § 360bbb-3(e)(1)(A)(ii)(I-III) of the Federal Food, Drug, and Cosmetic Act (FD&C Act) states: individuals to whom the product is administered are informed—

- (I) that the Secretary has authorized the emergency use of the product;
- (II) of the significant known and potential benefits and risks of such use, and of the extent to which such benefits and risks are unknown; and
- (III) of the option to accept or refuse administration of the product, of the consequences, if any, of refusing administration of the product, and of the alternatives to the product that are available and of their benefits and risks

We are being told that jabs are "safe and effective," that the PCR test is the "Gold Standard," and that masks "save lives." All of these statements are blatantly false! There are

also many alternative, less-invasive treatments and preventions available for Covid-19 at this time. We are not being truthfully informed, and therefore, their tactics are illegal!
